Students Preparing to Take Action in Policy and Advocacy

Did you know that pharmacy interns are allowed to immunize in 45 states?¹ However, New York is one of the five states in the United States in which pharmacy interns do not have this privilege. This has sparked great concern among our peers as there are high educational and practical benefits for students to have this right. The Interns as Immunizers bill is important to students as it will give us a greater ability to practice skills that will be necessary in our future profession. Practicing community pharmacists encourage students to get as much experience as possible under their supervision, however, our experience is currently limited due to the restriction placed on students in New York State. Students who travel out of state for their Advanced Pharmacy Practice Experiences (APPEs) have already immunized hundreds of patients without a single report of adverse reactions.

Throughout this academic school year, we have been serving as student liaisons to the Public Policy Committee, encouraging greater student involvement in legislation and advocacy at our respective schools of pharmacy. Through collaboration, and with a particular focus on the Interns as Immunizers bill, we have encouraged many of our Student Society of Health-System Pharmacy (SSHP) members to become advocates for the profession and will continue to raise awareness about the importance of student involvement in public policy. The power of the student voice is vital to the development of policies that will affect all of us now and as we graduate to become licensed pharmacists. Involvement is always a key aspect of advocacy and students at all of the pharmacy schools have displayed their passion for advocacy in more recent years. The current Interns as Immunizers bill was drafted by pharmacy students themselves to allow us to have the right that has already been granted in so many states. We, as a student body, want to advance our profession and see New York State join the vast majority of states in this field. Collaboration between NYS schools' SSHP branches has aided in letter writing campaigns and becoming a united front for pharmacy advocacy. Together with the Public Policy Committee and the newly appointed position of Public Policy Chair on each school's SSHP, students are now becoming more involved in legislative affairs.

One day that always stands out is Pharmacy Lobby Day in April. We want to encourage as many students, as well as pharmacists, to come out and show support for our profession. A major setback for student involvement in Lobby Day, however, is lack of confidence in the newest legislation and where we stand as a profession - but it is our job as students to increase confidence among our peers! Through raising awareness by means of letter writing, presentations, and collaboration with other professional organizations on our campuses, our goal is to prepare as many students as possible for active participation. As liaisons, we are able to transfer what we have learned through the Public Policy Committee to our student bodies to prepare them for this essential Lobby Day for our profession. Students are the future of the pharmacy profession, but legislators will make the decisions that impact us most. We must therefore become more involved to influenze

their decision making. As students we must actively engage in legislative affairs in order to advocate for our present and future profession and let our voices be heard.

What can students do to become active in public policy?

- Participate in activities with a professional organization at your school that addresses legislative matters
- Write a letter or meet with your legislators asking them for support on the Interns as Immunizers bill
- Attend Pharmacy Lobby Day in Albany on April 25th
- Attend ASHP's Student Advocacy day in Washington DC on March 6th and 7th
- Use social media to your advantage and encourage others to become involved
- Invite a pharmacist to present to your student body on policy updates and advocacy
